

# **CAMP PINNACLE COVID-19 PUBLIC SAFETY PLAN**

## **PHYSICAL DISTANCING**

1. Face coverings are encouraged for all Camp Pinnacle personnel who aren't vaccinated, and are recommended but not mandatory for all camp guests who aren't vaccinated unless in an indoor space where social distancing isn't possible.
2. All Camp Pinnacle personnel and campers do not need to physically distance themselves if they are vaccinated. Social distancing will be recommended during camper orientation for campers and staff who are unvaccinated.
3. Occupancy will be kept to 50% of maximum capacity.
4. In-person meetings will be held in open, well-ventilated spaces to the greatest extent possible.
5. Rainy Day Plan – a tent will be provided. Volunteers from the visiting group or camper personnel will be trained to sanitize surfaces before and after meals.
6. Camper and Group Registration will be handled on line and in advance to the greatest extent possible.
7. Campers will be assigned to cabins that will remain together for the entire camp session without mixing, to the largest extent possible.

## **PROTECTIVE EQUIPMENT**

1. Camp Pinnacle Staff will be provided with acceptable face coverings for those who need it. Groups and campers will be asked to bring masks. A reserve supply will be kept on hand.
2. Staff members are trained to be mindful and to refrain from sharing objects, to use caution when working on a shared surface; or, when in contact with shared objects or frequently touched areas, to wear gloves or sanitize or wash hands before and after contact to the greatest extent possible.
3. Campers and staff do not need to wear masks when outdoors as per **CDC** guidelines. Campers and staff who are not fully vaccinated are encouraged to wear a mask in crowded outdoor settings or during activities that involve sustained close contact with other people.
4. Campers and staff who are not vaccinated do not need to wear masks when indoors. Mask use indoors is strongly encouraged for people who are not fully vaccinated including children. No child under the age of 2 should wear a mask.
5. Campers and Staff who are fully vaccinated do not need to wear masks indoors unless asked to model good behavior for other campers and staff.

## **HYGIENE AND CLEANING**

1. Camp Pinnacle staff adheres to sanitation requirements from the Centers for Disease Control and Prevention (CDC) and Department of Health (DOH) and maintains cleaning logs on site that document date, time, and scope of cleaning.
2. Hand hygiene stations for personnel and guests including handwashing with soap, water, and paper towels, or a 60% alcohol-based hand sanitizer for areas where handwashing is not feasible is provided at the Office complex and the entry to all common areas including: Bess Wood Lounge, picnic tables, dining tent, White Birch stage, Arts & Crafts, Archery Range, Rec Halls and Snack Shop.
3. Training is provided to staff and group leaders.

4. Regular cleaning and disinfection will be conducted daily at the end of meals and shift change. Restrooms are sanitized daily and usage will be assigned as follows:
  - Campers – White Birch, Gym & Snack Shop
  - Retreats – lodge bathrooms (self-sanitized by groups) and Bess Wood
  - Staff – Christi Office bathroom

## **COMMUNICATION**

1. Camp Pinnacle posts signage to remind personnel and guests to adhere to proper hygiene, social distancing recommendations, appropriate use of PPE, and cleaning and disinfecting protocols. Guests and campers receive relevant information at the time of registration, through our website and will be provided with appropriate updates through counselors and staff when camp and retreats are in session.
2. A sign in/out sheet is kept at the office for guests and is maintained by office personnel.
3. If a worker or guest tests positive for COVID-19, notification will be made to state and local health departments by the Executive Director to cooperate with contact tracing efforts, including notification of potential contacts, such as workers or visitors who had close contact with the individual, while maintaining confidentiality required by state and federal law and regulations.

## **SCREENING**

1. Camp Pinnacle Staff and Campers who are overnight people will need a negative covid 19 test 72 hours prior to arriving at Camp. Staff and campers who are vaccinated or 90 days removed from having covid 19 will not need a negative covid 19 test prior to arriving at Camp.
2. All other personnel will undergo daily temperature checks upon arrive along with the covid 19 screening questions listed below
3. People who are fully vaccinated do not need to undergo routine COVID-19 screening questions.

## **SCREENING QUESTIONS**

The following questions will be asked daily upon arrival at camp for those who are unvaccinated.

- Have you had any COVID-19 symptoms in past 14 days?
- Have you tested positive for COVID-19 in past 14 days?
- Have you had close contact with confirmed or suspected COVID-19 case in past 14 days?
- Have you traveled out of the area in the last 14 days?

## **INDUSTRY SPECIFIC CAMP Protocols**

**Staggered drop off and pick up times for Day Campers coordinated by Camp Office**

**Gym Use – Games will be designed to promote social distancing to the greatest extent possible for unvaccinated people**

**Sports/Archery – Avoid close contact, Assigned bows and color coding arrows, sanitizing equipment between users to the greatest extent possible**

**Pool – SD at the Buddy Boards. Buddy Boards by cabin**

**Tabernacle – wiping down all instruments, microphones, sound equipment and computers. Designated users only. Propping doors open and wiping down surfaces**

**Sleeping accommodations & Rest time – alternating head to foot with bunk usage.**

**Masks are recommended for those who are vaccinated when social distancing is not possible in close quarters with poor ventilation. Families that wish their camper to be mask should send their kids with masks if unvaccinated. Wash or dispose daily. Provide 2 labeled water bottles, we can disinfect in our dishwasher.**

**\*Please note Camp Pinnacle will strongly encourage campers and staff to wear face coverings if a camper is closer than 6 feet.**

**If unable to social distance, all Camp Pinnacle personnel are strongly recommended to wear a face covering. In addition, Camp Pinnacle REQUIRES campers and staff NOT to wear masks during strenuous activity as this can lead to CO2 poisoning. Social Distancing is the recommended strategy for unvaccinated individuals.**
